

Electronic Court Filing (ECF)


OASIS LegalXML Electronic Court Filing Technical Committee (ECF TC)

Legal Portal Standards (LPX)


OASIS LegalXML Litigant Portal Technical Committee (LP TC)

Legal Portal Modules in LPX


